DELIVERY: 5.30pm to 6.00pm on Sunday 27th April (near Big W)

COLLECTION: 4.00pm to 4.30pm Sunday 4th May (Late collection fee \$20 per painting)

ENTRY FEE: \$5 per average size painting. \$10 per larger painting (over 250 cms. total perimeter but no larger than 450 cms.) Commission 12.5%.
Entries will be limited to **five (5)** paintings of average size or 2 large paintings + 1 small

LABEL: Title, Price & Artist's name on back (CHAS will provide a printed label for front attachment)

FORM & FEE: It is preferred payment be made direct to CHAS bank account

CONDITIONS OF ENTRY:

Please ensure that your paintings are framed to a high standard **with proper hanging cord or wire** (sharp ends to be wrapped), using D or triangular metal rings. Committee reserves the right to reject entries that do not comply or are deemed unacceptable for the exhibition.

LATE COLLECTION will incur a \$20 handling fee.
Note. It is essential to pick up paintings ASAP at closure of exhibition to enable dismantling and clearance of screens, and their return to Knightsbridge.

Able bodied persons willing to assist with this process would be appreciated.

INSURANCE is Exhibitor's responsibility - All care is taken but no responsibility accepted for loss/damage or uncollected work.

PROMOTION: The Society may allow works on display to be reproduced by any media.

ROSTER DUTY is essential to meet the servicing of over the 7 days exhibition period.
If you are unable to do a rostered session for any reason it will be necessary for **you to provide a replacement adult** to take your place.
